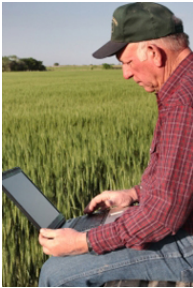

Much of what planners do impacts private property rights – comprehensive planning, land use regulation, environmental management, urban redevelopment are a few of many examples. Americans have a particular and historically-linked affinity for what they own. Americans also tend to view their right of ownership and the government's right to manage that ownership as a Constitutional issue, with their rights trumping those of society at large. The U.S. Supreme Court's 2005 Kelo decision highlighted these issues and brought them into intense public and state-legislative discussion. This webinar explores both the veracity of historical and contemporary claims about private property rights, and how to talk effectively about property rights with those who feel threatened by planning proposals.

In this session, presenters will review components of that guidance related to development of a comprehensive, historic preservation plan and how to implement that plan. This session will discuss Lancaster County’s *Cultural Heritage Element* of their County Comprehensive Plan as an example of a historic preservation plan and demonstrate how Lancaster County’s plan is being implemented. 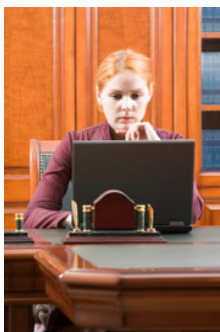

The work was a part of the [Economic Development Studio @ Virginia Tech](#) - and the students produced the study for leaders of [Sustain Floyd](#), a community based non-profit organization dedicated to the sustainable development of Floyd County, a rural county off the Blue Ridge Parkway in the New River Valley. Using Form Based Regulations to Sustain Neighborhood Character

Older neighborhoods in many cities are characterized by very narrow lots. The lots were typically platted at a time when it was customary to create such narrow lots and sell in multiples to individual buyers. This pattern results in nonconforming lots now owned by motivated sellers or developers. Unfortunately, residents of older neighborhoods become upset when this occurs as too often the resulting narrow house conflicts with neighborhood character. Norfolk has developed a form-based regulation approach to ensure that the resulting house will be consistent with the neighborhood. This session will highlight the Norfolk approach; how it was developed and how it is implemented through use of a Narrow Lot House Plans Catalog.

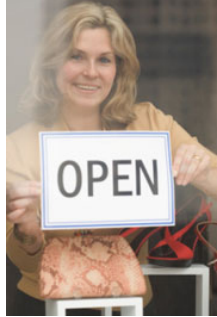

White-collar professional workers, in fields such as health care, engineering, information technology, accounting, architecture, are in high demand and companies are paying a premium for their services. These workers are being serviced by private third-party groups (headhunters). Blue-collar workers, including skilled technicians and those in fields such as advanced manufacturing, are being serviced by public third-party agencies (community colleges, workforce investment boards, employment commissions and staffing agencies).

The unserved workforce is caught in the middle. Neither the public nor private sector is serving this group. This segment of the workforce can be characterized as: younger with potential or upside; has some form of higher education; has good skill sets, but not billable skill sets, which are in demand; and are looking for a “professional” job paying a salary between \$25-\$50k. This is the critical mass of knowledge workers who are underemployed, overeducated, or who are leaving smaller regions for larger metropolitan areas for better employment opportunities.

This webinar will provide an introduction to the unserved workforce. Special attention will be given in the webinar to how regions and local governments, urban and rural, can work to create opportunities for the unserved workforce.

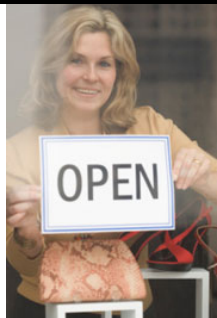
